Dear Ambassador Greer,

Thank you for your tireless work in fighting for a level playing field for American manufacturers, farmers, ranchers, workers, services providers, and energy producers across our country. We write to strongly support your efforts to secure a high-quality extension of the U.S.-Mexico-Canada Agreement (USMCA) that addresses key issues in concrete terms.

As you know, July 1 was the statutory date of the USMCA Joint Review, a process that provides the opportunity to ensure that partners are meeting their commitments and that the agreement evolves with the times to confront new challenges and take advantage of new opportunities.

The USMCA was the product of careful negotiation in close consultation with Congress, which yielded the strongest vote for any modern trade agreement. This created certainty in the U.S. to reshore production, create jobs, raise wages, promote innovation, and increase exports both to the region and globally. In a similar way, a strong Joint Review process can give further confidence to invest and grow exports.

We believe that the USMCA has delivered many positive benefits, but there are key improvements that can and should be made through the Joint Review process. Thus, while our desired result is an extension agreed to by the United States, Mexico, and Canada, we support the decision to prioritize outcomes over a deadline. We hope that Mexico and Canada work constructively and expeditiously to achieve that result.

Those outcomes should include securing market access that was promised six years ago but not meaningfully delivered; addressing new actions taken by Mexico and Canada that harm American manufacturers, agriculture, services providers, and workers; confronting unfair trade and investment practices from third countries that seek to undermine the North American economy and threaten American jobs; and rationalizing tariff structures to strengthen regional competitiveness in the global marketplace.

We look forward to your continued consultation with Congress on this vital effort to ensure that the USMCA continues to deliver strong results for American manufacturers, farmers, ranchers, workers, services providers, energy producers, and businesses of all size.
